**The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase:**

**On 31 August 2013 (“the date of the sale”):**

Balloting will be used to determine the order of priority. The persons or companies interested in purchasing any of the residential properties (“the registrants”) must follow the procedures below:-

1. Each of the registrants must submit
  - (a) the Registration of Intent duly completed and signed by the registrant;
  - (b) one cashier order in the sum of HK\$120,000 (or two cashier orders each in the sum of HK\$120,000 if the registrant is interested in purchasing two residential properties) made payable to “Kao, Lee & Yip”; and
  - (c) a copy of the registrant’s H.K.I.D. Card(s) or (as the case may be) Passport(s) or copy of Business Registration Certificate (if applicable) to Park Signature Sales Office at Shop ~~No. 2A, 3A & 10-13, L1~~ No. 17, L3, Discovery Park Shopping Centre, 398 Castle Peak Road, Tsuen Wan, Hong Kong (“Park Signature Sales Office”) during the period between 24 August 2013 to 29 August 2013 (24 August 2013: from 12:00 noon to 8:00 p.m.; 25 – 29 August 2013: from 11:00 a.m. to 8:00 p.m.) in order to register for eligibility to the balloting to take place on the date of the sale.
2. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the residential property(ies).
3. The registrants who have submitted the registration in accordance with paragraph 1 shall be eligible for the balloting and the registrants of each registration shall be entitled to only one lot.
4. The balloting will take place on 30 August 2013 and the balloting will be effected via a computer network. The ballot result, including “registration number”, “ballot result sequence” and “the check-in timeslot for registrants” shall be posted at Park Signature Sales Office at 4:00 p.m. on 30 August 2013. The opening hours of Park Signature Sales Office on 30 August 2013 are from 11:00 a.m. to 8:00 p.m.
5. The registrants shall personally attend Park Signature Sales Office on 31 August 2013 according to “the check-in timeslot for registrants” in the ballot result posted by the Vendor of Park Signature. The registrants must bring along their H.K.I.D. Card(s) or (as the case may be) Passport(s) or

Business Registration Certificate (if applicable) and the official receipt for the Registration of Intent. The registrants whose identities have been verified by the Vendor shall be eligible to select the residential properties in the order of priority according to the ballot result. Registrants who arrive at Park Signature Sales Office at any time later than “the check-in timeslot for registrants” assigned in the ballot result on 31 August 2013 shall not be eligible to select the residential properties in the order of priority according to the ballot result and the registration of such registrant will be deemed invalid.

6. Registrants of each registration will be entitled to purchase a maximum of 2 residential properties.

(a) In the event that a registrant selects a residential property from among those residential properties that have “\*” in Price List No.1 (for Park Signature) made available by the Vendor, then at the same time when such registrant selects the residential property, such registrant shall have the right to simultaneously select one Residential Parking Space of Park Signature, from among the Residential Parking Spaces of Park Signature as listed in the Price List of the Parking Space No.1 (as the case may be, according to respective eligibility therefor as stated in paragraph (4)(iii)(1) of Part 3 of Price List No. 1 (for Park Signature)) made available by the Vendor, for each residential property that the registrant purchases Provided that such right shall automatically lapse and shall not be exercisable at any time thereafter if the registrant fails to select the Residential Parking Space as aforesaid at that same time.

(b) In the event that a registrant selects a residential property from among those residential properties that do not have “\*” in Price List No.1 (for Park Signature) made available by the Vendor, such registrant shall not have any right to select any Residential Parking Space of Park Signature.

7. If the registrant has not purchased any residential property, the said cashier order(s) will be available for collection by the registrant in person at Park Signature Sales Office during the period starting from 2 September 2013 to 6 September 2013 from 11:00 a.m. to 8: 00 p.m.

After all “the check-in timeslot for registrants” in the ballot result have expired, the order of priority in the selection of the remaining residential properties will be on a first come first served basis. For such remaining residential properties, the following shall also apply:

(a) In the event that a purchaser selects a residential property from among those residential properties that have “\*” in Price List No.1 (for Park Signature) made available by the Vendor, then at the same time when such purchaser selects the residential property, such purchaser shall have the right to simultaneously select one Residential Parking Space of Park Signature, from among the Residential Parking Spaces of Park Signature as listed in the Price List of the Parking Space No.1 (as the case may be, according to respective eligibility therefor as stated in paragraph (4)(iii)(1) of Part 3 of Price List No.1 (for Park Signature)) made available by the Vendor, for each residential property that the registrant purchases Provided that such right shall automatically lapse and shall not be exercisable at any time thereafter if the purchaser fails to select the Residential Parking Space as aforesaid at that same time.

(b) In the event that a purchaser selects a residential property from among those residential properties that do not have “\*” in Price List No.1 (for Park Signature) made available by the Vendor, such purchaser shall not have any right to select any Residential Parking Space of Park Signature.

以抽籤方式決定優先次序，有意購買該等指明住宅物業的人士或公司（下稱：登記人）須遵從下列程序：

1. 登記人須於 2013 年 8 月 24 日至 2013 年 8 月 29 日期間（2013 年 8 月 24 日：中午 12 時至晚上 8 時；2013 年 8 月 25 日至 2013 年 8 月 29 日：上午 11 時至晚上 8 時）到香港荃灣青山道 398 號愉景新城購物商場一層 2A, 3A 及 10-13 三層 17 舖溱柏售樓處（下稱：溱柏售樓處）遞交：
  - (a) 已填妥及由登記人簽署的購樓意向登記表格，
  - (b) 一張港幣 \$120,000 本票（或如登記人有意認購兩個住宅物業，則遞交兩張每張港幣 \$120,000 之本票），抬頭人為「高李葉律師行」及，
