**The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase:**

**On 5 January 2015 (“the date of the sale”):**

The persons who are interested in purchasing any of the specified residential properties must follow the procedures below:-

1. A person who is interested in purchasing any of the specified residential properties must
  - (a) attend personally Park Signature Sales Office at ~~Shop No. 2A, 3A & 10-13, L1~~No. 17, L3, Discovery Park Shopping Centre, 398 Castle Peak Road, Tsuen Wan, Hong Kong (“Park Signature Sales Office”) between 10:30 a.m. and 11:00 a.m. on 5 January 2015 (no queuing before 10:30 a.m. outside Park Signature Sales Office will be allowed). No late comers will be accepted;
  - (b) bring one cashier order in the amount of HK\$120,000 (or two cashier orders each in the sum of HK\$120,000 if the registrant is interested in purchasing two residential properties) made payable to “Kao, Lee & Yip ” which shall be used for part payment of the deposit when purchasing a specified residential property and
  - (c) bring a copy of the person’s H.K.I.D. Card(s) or Passport(s) (as the case may be) or Business Registration Certificate (if applicable).
2. Balloting will be held to determine the priority of selection of the specified residential properties.
3. All persons who attend personally at Park Signature Sales Office between 10:30 a.m. and 11:00 a.m. on 5 January 2015 shall be registered for balloting by the Vendor. Each registrant shall be entitled to only one ballot drawing. Each registrant shall be entitled to purchase a maximum of 2 specified residential property.
4. Balloting will be held immediately after the registration is completed. The registrants shall proceed to select the specified residential properties available at the time of selection in the order of priority according to the ballot result. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any interested persons.
5. If the registrant does not purchase any residential property, the said cashier order(s) will be available for collection by the registrant in person at Park Signature Sales Office during the period starting from 6 January 2015 to 13 January 2015 from 11:00 a.m. to 8:00 p.m.

After the completion of the sale of specified residential properties by balloting mentioned above, the remaining available specified residential properties (if any) will be offered to be sold on a first come first served basis.

In case of dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any interested persons.

1. 有興趣購買任何上述列出之指明住宅物業之人士須：
  - (a) 於2015年1月5日上午10時30分至上午11時親身到達香港荃灣青山道398號愉景新城購物商場一層2A, 3A及10-13三層17舖溱柏售樓處(下稱: 溱柏售樓處)(賣方將不會接受於該出售日期上午10時30分前於溱柏售樓處輪候的人士)，所有遲到人士將不予受理；
  - (b) 帶備一張港幣\$120,000本票(或如登記人有意認購兩個住宅物業，請遞交兩張本票，每張港幣\$120,000)，抬頭人為「高李葉律師行」；及
  - (c) 帶備該人士的香港身份證或護照(視屬何情況而定)或商業登記證書(如適用)。
2. 揀選指明住宅物業的次序將以抽籤形式決定。
