Balloting will be used to determine the order of priority. The persons or companies interested in purchasing any of the residential properties ("the registrants") must follow the procedures below:-

1. Each of the registrants must submit

- (a) the Registration of Intent duly completed and signed by the registrant,
- (b) one cashier order in the sum of HK\$150,000 (or two cashier orders each in the sum of HK\$150,000 if the registrant is interested in purchasing two residential properties) made payable to "Kao, Lee & Yip" and
- (c) a copy of the registrant's H.K.I.D.
