Balloting will be used to determine the order of priority. The persons or companies interested in purchasing any of the residential properties ("the registrants") must follow the procedures below:-

- 1. Each of the registrants must submit
 - (a) the Registration of Intent duly completed and signed by the registrant,
 - (b) one cashier order in the sum of HK\$150,000 (or two cashier orders each in the sum of HK\$150,000 if the registrant is interested in purchasing two residential properties) made payable to "Kao, Lee & Yip" and
 - (c) a copy of the registrant's H.K.I.D. The registrants whose identities have been verified by the Vendor shall be eligible for the balloting and the registrants of each registration shall be entitled to only one lot.
