(2) 根據《一手住宅物業銷售條例》第52(1)條及第53(2)及(3)條。
According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, –

第52(1)條 / Section 52(1)

如某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的8個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第53(3)條 / Section 53(3)

如某人於某日期訂立臨時買賣合約時，但沒有於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則 – (i) 該臨時合約即告終止；(ii) 有關的臨時訂金即予沒收；及 (iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase – (i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

(3) 實用面積及屬該住宅物業其他指明項目的面積是按《一手住宅物業銷售條例》第8條及附表二第2部的計算得出的。

The saleable area and area of other specified items of the residential property are calculated in accordance with section 8 and Part 2 of Schedule 2 to the Residential Properties (First-hand Sales) Ordinance.

5% of the purchase price being further deposit shall be paid by the Purchaser within 60 days after signing of the PASP or within 14 days after the date of written notification to the Purchaser by the Vendor that the Vendor is in a position validly to assign the residential property to the Purchaser, whichever is the earlier.

(3) 買方簽署臨時合約後180天內繳付樓價90%作為樓價餘款或於賣方就其有能力將住宅物業有效地轉讓予買方一事向買方發出書面通知的日期後的14天內繳付，以較早者為準。

90% of the purchase price being balance of the purchase price shall be paid by the Purchaser within 180 days after signing of the PASP or within 14 days after the date of written notification to the Purchaser by the Vendor that the Vendor is in a position validly to assign the residential property to the Purchaser, whichever is the earlier.

(A1) 120天現金優惠付款計劃 120-day Cash Payment Plan (照售價減10%) (10% discount from the Price)

90% of the purchase price being balance of the purchase price shall be paid by the Purchaser within 14 days after the date of written notification to the Purchaser by the Vendor that the Vendor is in a position validly to assign the residential property to the Purchaser.

The Purchaser may apply for a standby first mortgage loan through Housing Finance Limited ("Finance Company"). Key terms are as follows:

備用第一按揭貸款

Standby First Mortgage Loan

- (a) 第一按揭貸款最高金額為臨時買賣合約內所列明之樓價的85%。
The maximum first mortgage loan amount shall be 85% of the purchase price as stated in the PASP.
- (b) 第一按揭貸款年期最長可達30年。
The maximum tenor of the first mortgage loan is up to 30 years.
