Employees, Relatives, Friends or Business Partners Cash Rebate

The Purchaser and his/her guarantor(s) (if any) must provide duplicate copies of their identity documents and all relevant supporting evidence as the Financing Company may think necessary. The documents provided will not be returned. All the Purchaser and his/her guarantor(s) (if any) must sign the relevant legal documents personally at the office of solicitors firm designated by the Financing Company.

All documents requested and/or to be requested by the Financing Company for processing the Super 88 First Mortgage Loan application must be delivered to the Financing Company as soon as possible but in no event later than forty-five (45) days prior to the anticipated loan drawdown date. In any event, the Financing Company shall not be responsible for any delay or postponement in processing and approving the Super 88 First Mortgage Loan application and/or any loss or damage suffered by the Purchaser/guarantor(s) as a result thereof or in connection therewith.

The handling will be waived if the Super 88 First Mortgage Loan is successful granted to the Purchaser.

For Purchaser who chooses (AX)Super 88 Artisanal Cash Payment Plan or (BX)Super 88 Bespoke Cash Payment Plan, if the Purchaser does not require the Super 88 First Mortgage Loan and has settled the balance of the Purchase Price in accordance with the ASP, the Purchaser shall be entitled to a cash rebate equivalent to 1% of the Net Purchase Price (“Super 88 First Mortgage Loan Cash Rebate”) offered by the Vendor.
