The Purchaser and his/her guarantor(s) (if any) must provide duplicate copies of their identity documents and all relevant supporting evidence as the Financing Company may think necessary. The documents provided will not be returned. All the Purchaser and his/her guarantor(s) (if any) must sign the relevant legal documents personally at the office of solicitors firm designated by the Financing Company.

In any event, the Financing Company shall not be responsible for any delay or postponement in processing and approving the Second Mortgage Loan application and/or any loss or damage suffered by the Purchaser/guarantor(s) as a result thereof or in connection therewith.

The approval or disapproval of the loan and the terms thereof are subject to the final decision of the Financing Company. Irrespective of whether the loan is granted or not, the Purchaser shall complete the purchase of the Property and shall pay the full Purchase Price of the Property in accordance with the Agreement.
