Any tender must be made in the Form of Tender (in prescribed form) which together with a Preliminary Agreement for Sale and Purchase (in prescribed form) signed by the tenderer and other relevant tender documents shall be enclosed in a sealed envelope and placed in the Tender Box located at 3A/F, New World Tower 2, 18 Queen’s Road Central, Central, Hong Kong from 2:00 p.m. to 5:00 p.m. on 11 October 2016 to 17 October 2016 (Monday to Friday, excluding Public Holidays) and from 9:00 a.m. to 11:00 a.m. on 18 October 2016.

任何投標必須以標書（指定格式）提出，標書連同由投標者簽署的臨時買賣合約（指定格式）和其他有關的投標文件須於2016年10月11至10月17日（星期一至星期五，不包括公眾假期）下午2時至下午5時以及2016年10月18日上午9時至上午11時期間，放入一個密封的信封內並投入放置在香港中環皇后大道中18號新世界大廈2期3A樓的投標箱內。

3. If a tender is accepted by the Vendor, the Vendor shall sign the Preliminary Agreement for Sale and Purchase submitted by the successful tenderer and send a written notice of acceptance together with a counterpart of the Preliminary Agreement for Sale and Purchase duly signed by the Vendor to the successful tenderer not later than the next succeeding working day of tender closing date.
