to “The Sales Office” from 11:00 a.m. to 8:00 p.m. in order to register for eligibility to the selection of any specified residential property.

Companies not incorporated in Hong Kong are not eligible to purchase any specified residential property of the Development, whether or not the specified residential property(ies) is/are included in this Information on Sales Arrangements.
