## POLL RESULTS OF ANNUAL GENERAL MEETING

The board of Directors (the “**Board**”) of New World Development Company Limited (新世界發展有限公司) (the “**Company**”) is pleased to announce that at the annual general meeting of the Company held on 21 November 2017 (the “**AGM**”), a poll was demanded by the Chairman of the AGM in accordance with the Company’s articles of association for voting on all proposed resolutions as set out in the notice of AGM dated 20 October 2017 (the “**Notice of AGM**”). All resolutions were duly passed by shareholders of the Company by way of a poll at the AGM. Tricor Tengis Limited, the Share Registrar of the Company, acted as scrutineer for the poll at the AGM. There were no shares entitling the holders to attend and abstain from voting in favour of the resolutions at the AGM as set out in Rule 13.40 of The Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and no shareholder of the Company was required under the Listing Rules to abstain from voting at the AGM.

In the Company’s circular dated 20 October 2017, no parties have stated their intention to vote against or to abstain from voting on any of the resolutions at the AGM.
