Balloting will be used to determine the order of priority. The persons or companies incorporated in Hong Kong (<u>companies not incorporated in Hong Kong are not eligible</u>) interested in purchasing any of the specified residential properties must follow the procedures below:-

1. A person who has already submitted Registration(s) of Intent ("the registrant(s)") (if the registrant is a company incorporated in Hong Kong, then any one of its directors) shall personally attend THE PAVILIA HILL Sales Office at G/F - 3/F, Cosco Tower, Grand Millennium Plaza, 183 Queen's Road Central, Sheung Wan ("THE PAVILIA HILL Sales Office") on first date of sale from 10.30 a.m. to 11 a.m.. The registrants must bring along their H.K.I.D. Card(s) or Passport(s) (as the case may be) or Business Registration Certificate, Certificate of Incorporation, the latest Annual Return of the registrant and H.K.I.D. Card of the Director of the registrant (if applicable), blank cheque(s) and the official receipt for the Registration of Intent. The registrants whose identities have been verified by the Agent appointed by the Vendor shall proceed to balloting. A higher priority in choosing specified residential properties will be given to registrants whose number of specified residential properties as indicated in the corresponding registration of intent is higher. The order of submissions of Registration of Intent will not have any impact on the order of priority for selecting the specified residential properties. A higher priority will be given to the balloting right of which the number of residential properties intended to be purchased as indicated in the corresponding Registration of Intent is higher (the maximum number of residential properties intended to be purchased as indicated is two and the minimum is one). If the Registration of Intent indicating the same numbers of residential properties to be purchased are more than one, the priority among the corresponding balloting rights will be determined by balloting.
