Balloting will be used to determine the order of priority. The persons or companies incorporated in Hong Kong (companies not incorporated in Hong Kong are not eligible) interested in purchasing any of the specified residential properties must follow the procedures below:-

1. A person who has already submitted Registration(s) of Intent ("the registrant(s)") (if the registrant is a company incorporated in Hong Kong, then any one of its directors) shall personally attend THE PAVILIA HILL Sales Office at G/F - 3/F, Cosco Tower, Grand Millennium Plaza, 183 Queen's Road Central, Sheung Wan ("THE PAVILIA HILL Sales Office") on first date of sale from 11a.m. to 11.30 a.m..
