**On 21 April 2022 and thereafter:**

1. First come first served. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any interested person.
2. Each of those person(s) and any one of the directors of each of the HK Corporate Purchaser(s) must submit the following to The Sales Office from 11:00 a.m. to 8:00 p.m. on 21 April 2022 and thereafter in order to register for eligibility to the selection of the specified residential properties remaining to be sold:
  - a. the Registration of Intent duly completed and signed by the registrant
  - b. each cashier order(s) are in the amount of HK\$200,000 (the number of cashier orders shall be same as the number of specified residential properties the registrant is interested in purchasing) made payable to “MAYER BROWN” which shall be used for part payment of the preliminary deposit when purchasing a specified residential property; and
  - c. a copy of the person’s H.K.I.D. Card(s) or Passport(s) (as the case may be) or (if the registrant is a HK Corporate Purchaser) copies of H.K.I.D. Card(s) or Passport(s) of the Director(s) of the HK Corporate Purchaser, Business Registration Certificate, Certificate of Incorporation and the latest Annual Return of the HK Corporate Purchaser.
3. Any company which is not incorporated in Hong Kong is not eligible to purchase any of the specified residential properties of the Development, regardless the specified residential properties are included in this Information on Sales Arrangements or not.

*If on any Date of Sale, (i) Tropical Cyclone Warning Signal No. 8 or above or Black Rainstorm Warning Signal is in effect in Hong Kong at any time between the hours of 7:00 a.m. and 6:00 p.m.; or (ii) where the Vendor considers that there being an event affecting the safety or order or public health in the Sales Venue and/or the vicinity; or (iii) the Hong Kong Government has imposed any restriction or issued any order relating to Coronavirus Disease 2019 (“COVID-19”) which requires people (except for exempted persons) in Hong Kong or any part thereof to stay indoor (such as stay-at-home, movement control or lockdown order) and/or requires the closure of the Sales Venue, then, for the safety of the Registrants and the maintenance of order at the Sales Venue or for compliance with the said restriction or order relating to COVID-19, the Vendor reserves its absolute right to change, postpone the selection of the Parking Space(s) and/or the Date of Sale to such other date, time, period, and/or place as the Vendor may consider appropriate.
