The above arrangements shall not affect the closing date and time of any subsequent tender exercise(s) under these Sales Arrangements. The Vendor reserves the right to reject the entry of any person into the Sales Office. The Vendor's decision in this regard shall be final and binding on all persons.

In such event, the Vendor will reject other offer(s) for that specified residential property.
