- (1) 每個柏傲灣住宅物業買家所認購之總車位個數不得超過2013年4月30日簽定之新批地文件第21566號特別條款第(50)條(a)所規定之3個;
 The total number of Parking Spaces that a Purchaser of THE PAVILIA BAY ("Specified Purchaser") selects should not exceed 3 as restricted by Special Condition (50)(a) of the New Grant No.21566 dated 30th April 2013;
- (2) 準買家應參閱發展項目期數的車位銷售說明書,以了解該發展項目期數車位的資料。
 Prospective purchasers are advised to refer to the sales brochure for parking space for the Phase of the Development for information on the parking spaces in the Phase of the Development.
- (3) (i) 柏傲灣車位支付條款 Terms of Payment of THE PAVILIA BAY Parking Spaces
 - (1) 買方簽署臨時買賣合約時需繳付車位售價之 5%。
 - 5% of the purchase price as the preliminary deposit upon signing of Preliminary Agreement for Sale and Purchase ("PASP").
 - (2) 買方簽署正式買賣合約時需再繳付車位售價之 5%作為加付訂金,並於5個工作天內簽署正式買賣合約。
 - A further 5% of the purchase price being further deposit shall be paid by the Purchaser(s) upon signing of the formal Agreement for Sale and Purchase ("ASP"). The ASP shall be signed within 5 working days after signing the PASP.
