## A. On 8 February 2021 :

The persons who are interested in purchasing any of the specified residential properties must follow the procedures below:-

- 1. Each of those persons and any one of the directors of each of the above mentioned companies incorporated in Hong Kong must submit:
  - a. the Registration of Intent duly completed and signed by the registrant (individual or company). Each person or company (whether in his/its own name or in joint names with any other party(ies)) may only submit a maximum of **1 Registration of Intent**. Each Registration of Intent will have an entitlement to purchase maximum of **1 specified residential property**.
  - b. for each Registration of Intent, one cashier order in the amount of HK\$200,000 made payable to "DEACONS" which shall be used for part payment of the preliminary deposit when purchasing a specified residential property; and
  - c. a copy of the person's H.K.I.D. Card(s) or Passport(s) (as the case may be)

to "Additional Designated Venue" on 8 February 2021 from 10:00 a.m. to 10:30 a.m. in order to register for eligibility to balloting.

- 2. Late submission of registration will not be accepted. The Registration of Intent is personal to the registrant and shall not be transferrable.

The balloting will take place after 10:30 a.m. on 8 February 2021 at "Additional Designated Venue" for the purposes of determining the order of priority of registrants in selecting and purchasing specified residential properties ("the order of priority"). The balloting will be performed by computer.
