the Vendor shall be entitled to terminate the licence agreement if (i) the Purchaser fails to make any payment in accordance with the Agreement (if applicable, including all revised agreement(s) for sale and purchase and supplemental agreement(s) required to be entered into under the Standby Completion Extension Benefit); (ii) the Purchaser fails to complete the sale and purchase of the residential property in accordance with the Agreement (if applicable, including all revised agreement(s) for sale and purchase and supplemental agreement(s) required to be entered into under the Standby Completion Extension Benefit); (iii) the Purchaser breaches any terms under the licence agreement; or (iv) the occurrence of such circumstances resulting in termination of the licence agreement pursuant to the provisions of the licence agreement.
- (ix) 任何其他由賣方施加的條款及細則。  
Early Move-in Benefit is subject to other terms and conditions as prescribed by the Vendor.

Subject to the following terms, if the Purchaser signs the preliminary agreement for sale and purchase, the Purchaser will be provided with the decoration, furniture and/or chattels applicable to the residential property purchased by the Purchaser (“relevant residential property”) as set out in the Table 1 below (the “Furniture”) free of charge. For the avoidance of doubt, the First 3 Years Maintenance Offer as set out in paragraph (4)(iii)4 does not apply to the Furniture.

In particular, no warranty or representation whatsoever is given as to the Furniture's condition, state, quality, fitness or as to whether any of the Furniture is or will be in working condition. For the avoidance of doubt, without prejudice to generality of the foregoing, the First 3 Years Maintenance Offer as set out in paragraph (4)(iii)4 does not apply to the Furniture.

(IV) 該傢俱將於按照正式合約完成有關住宅物業之買賣時以「現狀」交予買方。「現狀」指該傢俱於交易日當天之狀況。

The Furniture will be handed over to the Purchaser on the completion of the sale and purchase of the relevant residential property under the Formal Agreement in an "as is" condition, meaning the condition of the Furniture is or will be as at the date of completion.

(V) 如賣方按照(i)本價單之條款及(ii)相關許可協議之條款，給予買方許可證以准許買方在完成有關住宅物業之買賣前佔用有關住宅物業，以下(a)至(c)分條將會適用（即使本價單之第(4)(iii)6段載有任何規定）：-

(a) 賣方會同時給予買方在許可期內使用提供在有關住宅物業的該傢俱的權利（惟受制於相關許可協議之條款），在此情形下，該傢俱將於許可期開始時以「現狀」交予買方。「現狀」指該傢俱於許可期開始當天之狀況；

(V) If the Vendor grants to the Purchaser a licence to occupy the relevant residential property prior to completion of sale and purchase of the relevant residential property on such terms and conditions as set out in (i) this Price List and (ii) the relevant licence agreement, the following sub-clauses (a) to (c) will apply notwithstanding anything provided in this paragraph (4)(iii)6 of this Price List :-

(a) the Vendor will at the same time grant to the Purchaser a right to use the Furniture provided in the relevant residential property during the licence period (subject to such terms and conditions in the relevant licence agreement) whereupon the Furniture will be handed over to the Purchaser on the commencement of the licence period in an "as is" condition, meaning the condition of the Furniture is or will be as at the commencement of the licence period;

(b) the Purchaser shall be solely responsible for the maintenance and repair of the Furniture during the licence period at his own cost and expense;

(c) the Vendor shall not be responsible for remedying any defects to any of the Furniture or any part thereof irrespective of whoever caused such defects and howsoever such defects are caused; and

(d) the Purchaser hereby specifically releases and discharges the Vendor from the obligation to deliver the Furniture to the Purchaser upon completion of the sale and purchase of the relevant residential property under the Formal Agreement by virtue of the Vendor granting the aforesaid licence to the Purchaser, and the Furniture shall be deemed to have been delivered by the Vendor to the Purchaser on completion of the sale and purchase. The Purchaser shall not raise any objection or requisitions whatsoever in this respect to the Vendor.

Any failure on the part of the Vendor (due to any reason whatsoever) to deliver the Furniture or any part thereof, to the Purchaser on completion of the sale and purchase of the relevant residential property shall not entitle the Purchaser to terminate or rescind the sale and purchase of the relevant residential property or the Formal Agreement.
