- (1) 準買家應參閱發展項目的售樓說明書，以了解該項目的資料。

Prospective purchasers are advised to refer to the sales brochure for the development for information on the development.

- (2) 根據《一手住宅物業銷售條例》第52(1)條及第53(2)及(3)條，-

According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -

第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的8個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第53(3)條 / Section 53(3)

如某人於某日期訂立臨時買賣合約時，但沒有於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則 - (i) 該臨時合約即告終止；(ii) 有關的臨時訂金即予沒收；及 (iii)

擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase -

(i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

- (3) 實用面積及屬該住宅物業其他指明項目的面積是按《一手住宅物業銷售條例》第8條及附表二第2部的計算得出的。

The saleable area and area of other specified items of the residential property are calculated in accordance with section 8 and Part 2 of Schedule 2 to the Residential Properties (First-hand Sales) Ordinance.

5% of the purchase price being further deposit shall be paid by the Purchaser within 30 days after signing of the PASP.

Each such Purchaser must decide whether to purchase such a residential parking space of FLEUR PAVILIA and must enter into a relevant sale and purchase agreement within the period as prescribed by the Vendor, failing which that Purchaser will be deemed to have given up the Purchase Option. The Purchase Option is not transferrable. Price List and sales arrangement details will be determined by the Vendor at its sole and absolute discretion and will be announced later.

In particular, no warranty or representation whatsoever is given as to the Furniture's condition, state, quality, fitness or as to whether any of the Furniture is or will be in working condition. For the avoidance of doubt, without prejudice to generality of the foregoing, the First 3 Years Maintenance Offer as set out in paragraph (4)(iii)4 does not apply to the Furniture.

The Furniture will be handed over to the Purchaser on the completion of the sale and purchase of the relevant residential property under the Formal Agreement in an "as is" condition, meaning the condition of the Furniture is or will be as at the date of completion.

(a) the Vendor will at the same time grant to the Purchaser a right to use the Furniture provided in the relevant residential property during the licence period (subject to such terms and conditions in the relevant licence agreement) whereupon the Furniture will be handed over to the Purchaser on the commencement of the licence period in an "as is" condition, meaning the condition of the Furniture is or will be as at the commencement of the licence period;

(b) the Purchaser shall be solely responsible for the maintenance and repair of the Furniture during the licence period at his own cost and expense;

(c) the Vendor shall not be responsible for remedying any defects to any of the Furniture or any part thereof irrespective of whoever caused such defects and howsoever such defects are caused; and

(d) the Purchaser hereby specifically releases and discharges the Vendor from the obligation to deliver the Furniture to the Purchaser upon completion of the sale and purchase of the relevant residential property under the Formal Agreement by virtue of the Vendor granting the aforesaid licence to the Purchaser, and the Furniture shall be deemed to have been delivered by the Vendor to the Purchaser on completion of the sale and purchase. The Purchaser shall not raise any objection or requisitions whatsoever in this respect to the Vendor.

The Vendor reserves the right to substitute the Furniture with items of similar design, style, size, finishes or colour without further notice to the Purchaser.

(VIII) 如賣方未能於有關住宅物業的成交日將該傢俱或其任何部分交予買方(不論基於任何原因)，買方亦不得以此為理由終止或撤銷有關住宅物業之買賣或正式合約。

Any failure on the part of the Vendor (due to any reason whatsoever) to deliver the Furniture or any part thereof, to the Purchaser on completion of the sale and purchase of the relevant residential property shall not entitle the Purchaser to terminate or rescind the sale and purchase of the relevant residential property or the Formal Agreement.

(IX) 若有關住宅物業之買賣根據正式合約內任何條款或法律上被廢除、取消或撤銷，賣方均沒有責任將任何該傢俱交予買方。

Should the sale of relevant residential property be annulled, cancelled or rescinded pursuant to any provisions of the Formal Agreement or at law, the Vendor is not obliged to deliver or hand over to the Purchaser any of the Furniture.

This Furniture Benefit is subject to other terms and conditions.
