(b) For other cases where a purchaser purchases a parking space, a sum of HK\$5,000 will be paid by way of credit card for part payment of the preliminary deposit or a cashier order of HK\$5,000 being part of the preliminary deposit shall be made payable to "MAYER BROWN" or 「孖士打律師行」, and please prepare a cheque payable to "MAYER BROWN" or 「孖士打律師行」 to pay for the balance of the preliminary deposit.
