- (2) The Vendor does not undertake and is under no obligation to review, consider or accept the highest offer or any offer at all for the purchase of any specified residential property. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has the absolute right to accept any offer at or before the closing time of the tender and/or to change the closing date and/or time of the tender and/or the place where the sale will take place in respect of any specified residential property from time to time by amending and/or issuing the Information on Sales Arrangements.
- (3) Tender notice and other relevant tender documents will be made available for collection free of charge at Sales Office 1 from 2:00 p.m. to 5:00 p.m. daily between 17 June 2021 and 3 October 2021 (both days inclusive).
- (4) Notwithstanding anything herein provided, if typhoon signal no.8 or above or black rainstorm warning signal is in effect in Hong Kong at any time from 9:00 a.m. to 11:00 a.m. on the day on which the closing time of the tender falls, the closing time of the tender will automatically be postponed to 11:00 a.m. on the next day and in respect of which no typhoon signal no.8 or above or black rainstorm warning signal is announced. The above arrangements shall not affect the closing date and time of any subsequent tender exercise(s) under these Information on Sales Arrangements.
- (5) The tender sale of a specified residential property is subject to availability. Where the Vendor has accepted a tender for a specified residential property, no tender sale of that specified residential property will be carried out on the subsequent date(s) of sale. Persons interested in submitting tenders of the specified residential properties are reminded to (i) enquire with the Vendor; and/or (ii) read the latest register of transactions of the Phase so as to ascertain whether a particular specified residential property is still available for tender on a date of sale. Although a specified residential property may be available for tender on a date of sale, it may become unavailable during that date of sale because the Vendor may accept a tender within 7 working days after the close of a previous tender exercise. In such event, the Vendor will reject other offer(s) for that specified residential property.
