No late comers will be accepted;

- (b) bring one cashier order in the amount of HK\$200,000 made payable to "Kao, Lee & Yip" which shall be used for part payment of the deposit when purchasing a specified residential property and
- (c) bring a copy of the person's H.K.I.D. Card(s) or Passport(s) (as the case may be) or Business Registration Certificate (if applicable).
- 2. Balloting will be held to determine the priority of selection of the specified residential properties.
