Balloting will be used to determine the order of priority. The persons or companies interested in purchasing any of the residential properties ("the registrants") must follow the procedures below:-

- 1. Each of the registrants must submit
 - (a) the Registration of Intent duly completed and signed by the registrant,
 - (b) one cashier order in the sum of HK\$120,000 (or two cashier orders each in the sum of HK\$120,000 if the registrant is interested in purchasing two residential properties) made payable to "Kao, Lee & Yip" and
 - (c) a copy of the registrant's H.K.I.D. Card(s) or (as the case may be) Passport(s) or copy of Business Registration Certificate (if applicable) to Park Signature Sales Office at Shop No. 2A, 3A & 10-13, L1, Discovery Park Shopping Centre, 398 Castle Peak Road, Tsuen Wan, Hong Kong ("Park Signature Sales Office") on 3 December 2013 (from 2:00 p.m. to 8:00 p.m.) and during the period of 4 December 2013 to 6 December 2013 (from 11:00 a.m. to 8:00 p.m.) in order to register for eligibility to the balloting to take place on 7 December 2013.
