Remark 1: At the extraordinary general meeting held on 19 June 2020, the shareholders of the Company approved the Share Consolidation (as defined in the circular of the Company in relation to the same dated 1 June 2020 (the "**Circular**")). The Share Consolidation became effective on 23 June 2020. For detail of the Share Consolidation, please refer to the Circular.

Remark 2: All share options under the share option scheme adopted on 24/11/2006 outstanding at close of preceding month were either exercised or lapsed before the Share Consolidation took effect. Therefore, no Share Options Adjustments (as defined in Remark 4) are made to these figures.

Remark 3: These share options under the share option scheme adopted on 22/11/2016 lapsed before the Share Consolidation took effect. Therefore, no Share Options Adjustments (as defined in Remark 4) are made to this figure.

Remark 4: As a result of the Share Consolidation, adjustments were made to the number of shares subject to, and exercise price of, the outstanding share options under the share option scheme adopted on 22/11/2016 (the "**Share Options Adjustments**"). The Share Option Adjustments took effect on 23 June 2020. For detail of the Share Options Adjustments, please refer to the announcement of the Company dated 23 June 2020. This figure has therefore been adjusted accordingly.
